What data do we collect?

Aspecto Unistudy collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Browser data (IP-Address, User agent, Device information, etc.)
- Educational History (Degrees, Grades, etc.)

How do we collect your data?

You directly provide Aspecto Unistudy with most of the data we collect. We collect data and process data when you:

- Voluntarily fill out the contact form
- Contact us via email or social media

Aspecto Unistudy may also receive your data indirectly from the following sources:

- When a purchase is made
- If a site administrator logs in

How will we use your data?

Aspecto Unistudy collects your data so that we can:

- Process your order
- Email you with deadline reminders and service offering that are relevant to you
- Statistics

When Aspecto Unistudy processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Aspecto Unistudy will keep your data for 6 months after placement in Aspecto unistudy. Once this time period has expired, we will delete your data.

Who has access to your data?

Apart from ourselves we provide limited and temporary access to third parties. This access is limited to both the time that external access is necessary and the data required to fulfill the intent of the access.

What are your data protection rights?

Aspecto Unistudy would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Aspecto Unistudy for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that Aspecto Unistudy correct any information you believe is inaccurate. You also have the right to request Aspecto Unistudy to complete information you believe is incomplete. **The right to erasure** — You have the right to request that Aspecto Unistudy erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Aspecto Unistudy restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Aspecto Unistudy's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Aspecto Unistudy transfer the data that we have collected to another organization, or directly to you, under certain conditions.
